Martha Hall Findlay, BA, LLB, ICD.D

Martha recently came out of retirement to become the Director and Palmer Chair at the School of Public Policy at the University of Calgary.

Before retiring, Martha led Suncor Energy's efforts to address the nexus of climate and energy, first as Suncor's Chief Sustainability Officer and then as Chief Climate Officer. Martha was instrumental in developing and playing a leadership role with the multi-company Oil Sands Pathways to Net Zero by 2050 Alliance.

The British High Commission and the Canada Climate Law alliance named her a Canadian Climate Champion in 2021 and she was one of Canada's Clean50 for 2022. The Energy Council listed her as a top global female oil and gas executive and one of the top 275 women influencers. She was awarded the Queen Elizabeth II's Platinum Jubilee Medal in 2023.

Prior to joining Suncor, Martha was the President and CEO of the Canada West Foundation, an important Canadian think-tank, where she focused on public policy recommendations for the economic and social prosperity of Canada and its western provinces.

She has written book chapters, essays, articles and op-eds for national publications and has frequently appeared as a thought leader in national print and broadcast media in both English and French.

She has 30+ years of experience as a corporate lawyer, international trade expert, senior executive and entrepreneur, supporting both major multinationals and startups, primarily in wireless telecommunications and energy, in Canada, the US and Europe.

A twice-elected MP, she served in the Official Opposition's shadow cabinet as critic for International Trade; Finance; Transport, Infrastructure and Communities; and Public Works and Government Services. She served on the House of Commons Standing Committees for those portfolios.

Since 2017 she has been on the deputy minister of International Trade's Trade Expert Advisory Council. She is a member of the Asia Business Leaders Advisory Council, the executive committee of the Canada-Korea Forum and a Canada-U.S. Expert Group, preparing for upcoming trade discussions with the U.S.

Martha's community engagement includes serving as an advisory council member, board director and/or executive for numerous policy, environmental, community and cultural organizations, including the Canadian Chamber of Commerce, Positive Energy (University of Ottawa), Protein Industries Canada, the Glenbow Museum and CKUA Radio Network. She recently served on MaRS's energy advisory board and the advisory council for Avatar Innovations. She sits on TELUS's board of directors.

A Canadian Championships silver medalist in alpine skiing (1976), she recently returned to the sport to serve six years on Alpine Canada's board, her last two as chair.

Martha has a BA in International Relations from the University of Toronto and an LLB from Osgoode Hall Law School. She also holds the Institute of Corporate Directors ICD.D designation.



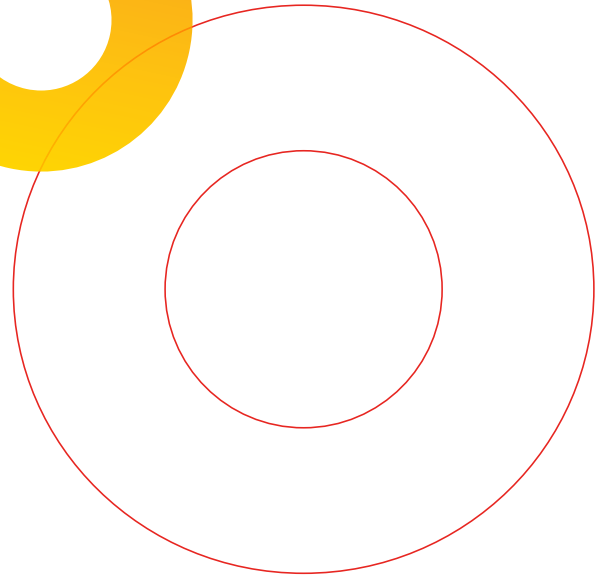
Developing Canada's future policy leaders

The MPP is a student-centred, transformative one-year integrated program that hones skills through hands-on training. Graduates go on to policy careers in both the public and private sectors.

Thanks to this commitment, the School of Public Policy will continue playing a major role in training the policy makers of the future by providing world-class policy education.

The Master of Science in Sustainable Energy Development (SEDV) is a leading interdisciplinary graduate program providing a balanced education related to energy and environmental management. The students benefit from the teaching and expertise of faculty members from the School of Public Policy, Haskayne School of Business, Schulich School of Engineering, School of Architecture, Planning, and Landscape, and the Faculty of Law. We prepare graduates for senior roles in energy, in both the public and private sector, with a focus on the science of energy systems, and practical experience in conventional and novel project development, including fossil fuels, the transition to lower carbon sources of energy, demand-side management, energy efficiency, renewables and offsets. Graduates from the SEDV program understand the theory and have acquired skills in understanding the impacts of energy development on the environment, Indigenous Peoples, communities and the economy.



Social Policy & Health

Our goal is to improve the options available to policymakers addressing the social, health, and well-being challenges of our time. Our community engaged research teams develop and observe practical options aimed at cutting through polarizing rhetoric and unlocking policy-making potential. We deploy a range of quantitative and qualitative methods within two key policy areas:

This research program focuses on producing evidence-based assessments of, and policy options for, the way social programs are designed and delivered.

International Policy & Trade

The International Policy and Trade (IPT) Research Division focuses on understanding global trade and investment and the analysis of policies related to the security of Canada's borders, its assets abroad, cyber-space, and the security of its economic relationships. With increasing geopolitical competition between the world powers, IPT is currently focused on the false Russian narratives in the ongoing war in Ukraine.

IPT Research Portfolio: The Indo-Pacific

With the news of Chinese interference in Canadian elections, another region of interest was added to the IPT research portfolio: the Indo-Pacific. The team is monitoring and analysing Canadian-Chinese news media to identify key messages being spread within the Chinese diaspora in Canada, and Canadian mainstream media.

This work is attracting interest from government agencies allowing IPT to continue to work with the Global Affairs Canada's Rapid Response Mechanism group and establish a new partnership with Privy Council Office. Scientific Director, JC Boucher, traveled to the Indo-Pacific to deepen his understanding of the challenges and expand the IPT network with key stakeholders operating in the region.

Ten conferences in Canada and internationally where IPT shared knowledge on key global issues.

Over 15 presentations at outreach events highlighting IPT expertise in disinformation and foreign interference.

JC Boucher participated in NATO StratCom organized by NATO Strategic Communications Centre of Excellence in Riga, Latvia, in June 2023 and NATO Communicators Conference in Paris, France, in September 2023. Both of these events drew hundreds of experts, practitioners, and top-level policymakers from across disciplines and around the world. These invitation-only events underline the unique input IPT has to offer to the global discussion on challenges posed by the changing geopolitical landscape.

Canadian Network on Information and Security (CANIS)

CANIS successfully wrapped up its third year with the last annual conference, which took place from March 20-22, 2024. More than 70 participants traveled to Banff for a two-day conference discussing foreign interference in democratic elections. A plethora of views were shared in this invitation-only event that brought together speakers from all across the world, including Germany, the UK, Singapore, Japan, and Taiwan among others. Many diverse perspectives were shared on the meddling techniques coming from large powers, such as China and Russia.

HACKATHON

Canadian Network on Information and Security

In November 2023 IPT organized another Hackathon, this time in collaboration with Global Affairs Canada's Rapid Response Mechanism who provided the dataset and a creative problem to over 400 registered participants. The Schulich Ignite led the event, centered around data science and visualization, to encourage students and scholars alike to visualize data to benefit policymakers and government officials. Submissions to this international event came from Canada, India, the U.S., Vietnam, Belarus, etc.

SUMMER SCHOOL

Canadian Network on Information and Security

May 2023 was the last iteration of CANIS Summer School open to defence and security professionals and young scholars. Throughout the week, the students learned about interdisciplinary perspectives on the realm of disinformation and security. They also engaged in a wargame simulation where they applied the theoretical knowledge gained in class to potential information operation.

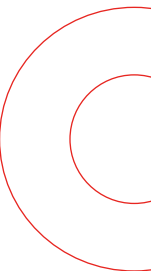
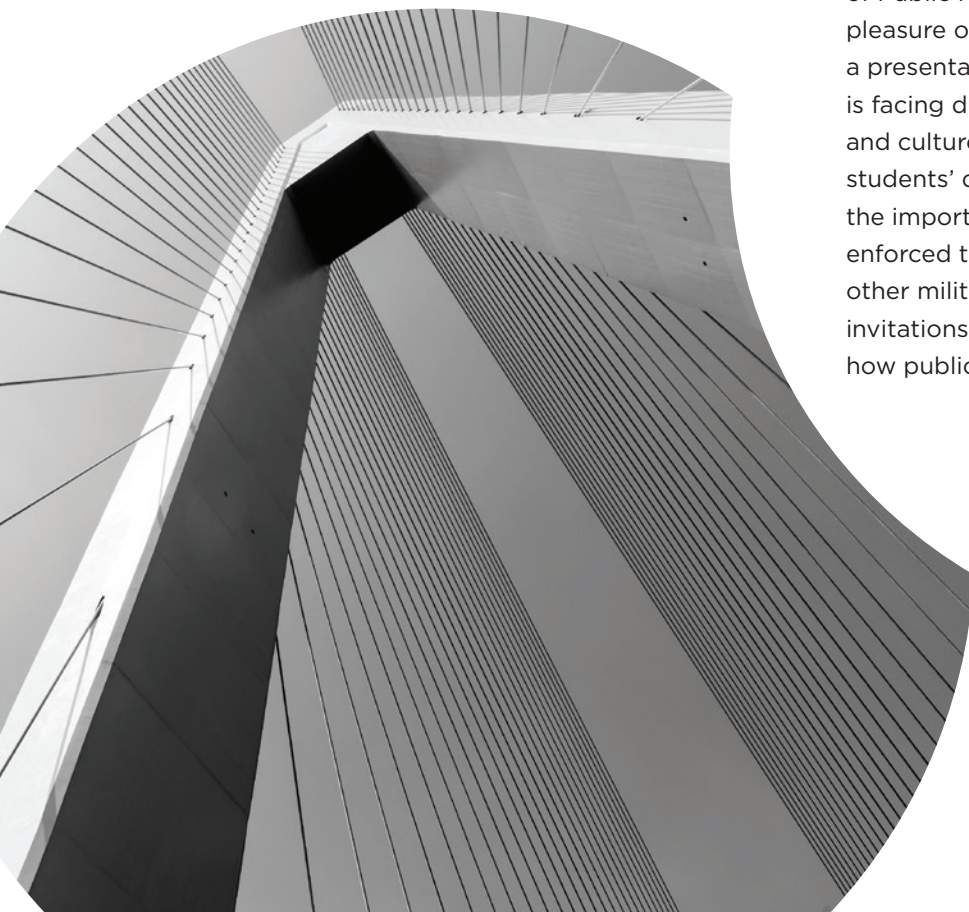
Summer Workshops

As part of the partnership with the Network for Strategic Analysis (NSA) and the Canadian Defence and Security Network (CDSN), IPT participated in two summer workshops.

The workshop organized by NSA in July 2023 brought together young scholars who were trained on computer-assisted text analysis that would develop their capacity to process substantial texts on security and defence issues. The CDSN Summer Institute provided a new, cross-sector professional development and networking opportunity for senior members of the Canadian Armed Forces, the Public Service, academia, and the media. JC Boucher traveled to Ottawa in August 2023 to teach as one of the regular instructors at the CDSN Summer Institute. The year 2023 ended with a weeklong workshop in Munster, Germany where IPT partnered with a university in Munster and brought academics, young researchers, and data experts to work together on the development of AI methods that can be used in public policy research.

Royal Canadian Navy (RCN)

One of the highlights of last year's outreach was the Royal Canadian Navy's (RCN) visit to the School of Public Policy in November 2023. IPT had the pleasure of hosting the Vice-Admiral who delivered a presentation on the challenges and issues the RCN is facing due to the latest scandals, hiring issues and culture change. The Vice-Admiral was open to students' questions about the future of the RCN and the importance of good defence policy. The visit enforced the strong relationship with the RCN and other military institutions that repeatedly accept invitations from IPT to discuss their work and explain how public policy decisions affect their operations.
